### 5. President's Report

- The President advised that further water restrictions seem to be on hold for the next 12 months. However the association wants to know what actions have been taken by clubs affected by the current water restrictions and if there is to be any further restrictions what plans they have in place.
- A congratulations was given to all clubs in regards to phoning thru results at the end of the past season. They came thru prompty and in a courteous manner. Well Done!
- Congratulations to all teams that made the finals especially to those who won them. Good luck for next season.

#### 6. Treasurer's Report (refer to attached report)

- (a) Moved Graham Sandman (Treasurer), seconded Warren Cram (East Keilor) that the Treasurer's Report be accepted – **Carried**.
- (b) Approval was sought for all accounts to be moved from the Bendigo Bank to the NAB. It is seen to pay more interest and less fees:

Moved Graham Sandman (Treasurer), seconded Rob Haines (Parkville) that the accounts be moved to NAB. - Carried.

#### 7. Match and Permit Committee Report

- The proposed changes to the current default rule was discussed in great detail last meeting, however some feedback has been received from some clubs however the match and permit committee feel that the time should be extended for feedback from all clubs. All ideas will be considered up until the next meeting. There was also discussion about forming a sub committee to help work thru the many suggestions given by clubs. All interest in being on this committee should be forwarded to Larry Pelly or Peter Olney.
- Peter Olney re-iterated that this is just a proposal at this stage and that there may be many other ways to refine these rules. The idea is to reduce defaults and increases the number of matches played. This will also help to reduce the amount of fines occurring thru defaults.
- There were a few protests and appeals that occurred during the finals. An issue with Keilor Park was resolved by the club and the Match and Permit Committee agree on penalty. The issue between West Brunswick and Fawkner is still awaiting a response from Fawkner TC.
- During the Semi Finals there was an issue between Fawkner and Coburg with alledged foot faulting. The player receiving the serve called the foot fault which is not allowed. A Tennis Vic document found by Maria Keys states that when a match is not chair umpired the receiver can't call foot faults. In resolving this issue Match and Permit decided that the last 2 sets would be replayed due to the incdent of foot faults being called. These sets were played the following Thursday night and the Grand Final was played at the conclusion of the semi final. A tie breaker was played in the Grand Final and a result was made. The games were played under Match and Permit supervision.
- The rules of tennis should be available at all clubs. It was suggested that association distrubute a laminated copy of these rules to each club so that it could be displayed in the club rooms.
- During round 13 two teams signed a result card as a draw. One team changed the result card after the other team had left. It was found that the result was correct and changed. It is seen to be a legal document so please make sure it's correct when you sign it.
- As of next season St Matthew's TC is to be known as Moomba Park Grading will be done at 7pm 9<sup>th</sup> December so any changes should be directed to Larry before 7pm.
