7. Match and Permit Committee Report

- Season been running smoothly so far
- When it comes to emergency and additional registration players they can't be seen to be strengthening the team as per the by laws. Player's history, results on the night and who they are playing for as an emergency for are all considered. An additional registration can only be looked at once a player has actually played in the team. Some clubs do advise the association of strong emergencies but we do look at all stats every week. It was suggested that A Grade juniors shouldn't be allowed to play D+ as an emergency. Games can be taken off an emergency if they are seen to be too strong and stengthening the team. A reminder was given that emergencies should be of an appropriate standard. If you are wanting to additionally register someone who is a little stronger in yoru team you could always look at deregistering a player of similar standard.
- It is strongly discouraged for teams to withdraw, fines may need to be increased if it keeps happening
 as frequently.
- There have been many emails received about player behaviour. A reminder to all players to try and behave appropriately and to try and settle any issues that arise before they escalate into bigger issues.
 Club captains should try and stop the problem and if not adhered to then ask them to leave. It can be put into writing and sent to the association aswell as the opposing club.
- There has been some confusion on the rule about arriving late. Start time is 7pm and at 715pm play must have commenced if not the first set must be forfeited. If teams choose to play a different set instead then that is ok. There must be continuous play of sets. Once it is played out of order then neither club can try and claim an earlier set later down the track. The team that is in attendance can decline to play out of order and therefore take the first set.
- All finals results are to be posted online promptly. Round 14, semi and Grand finalresults to be phoned
 thru aswell to 93549019. All details for hosting finals will be emailed to clubs. The result sheets will be
 found in the back of the result card books currently being used thru the season. All host clubs are to
 print out the hosting rules for finals and be available at the club.
- Oak Park, Glencairn and Coburg have advised that they are unable to host finals this season due to
 works being undertaken at their clubs. Craigieburn has only 2 courts available due to works being
 undertaken on the lights. It is assumed that all other clubs have facilities avavilable for hosting.
- Next seasons team entries close on the 10th June. They should be emailed to the Chairman. Don't forget to fill out the grade contact sheet in full and attatch it to the email aswell.
