#### 8. Match and Permit Committee Report

- So far the season has run quite smoothly.
- Additional Registrations close with the Chairman at 7pm on 23<sup>rd</sup> October for the Ladies, 25<sup>th</sup> October for the Men's and 31<sup>st</sup> October for the Mixed.
- Light testing continues thanks to clubs who have completed upgrades to their lights when requested. Only 4 courts in the association have a lux reading under 200.
- All clubs need to make sure they have access to all necessary facilities at 7pm when competition commences.
- A by-law was introduced last season about players playing under assumed names. This is still
  happening, so a reminder to all clubs to keep an eye on players as penalties does apply.
- There have been issues with matches being abandoned under protest when there is a debate about whether a washout should be agreed upon. Players aren't allowed to leave the venue until a decision is made or the result sheet has been signed under protest. If a resolution can't be reached then an M&P committee member should be phoned to get an answer on how to proceed.
