6. President's Report

The extreme weather policy has been released by Tennis Victoria. As we are affiliated with Tennis Victoria we need to ensure our rules are consistent with these guidelines. 8. Match and Permit Committee Report

- Further light testing has been undertaken. Clubs are reminded that even if your courts meet
 the average minimum requirement, you should sill check the report to see if there are any
 points on the court where the lighting is uneven and look at ways to improve this before it
 becomes a problem. Clubs must ensure lights are fixed ASAP when they go out. The
 NSNTA can require Clubs not use courts where lights are out.
- The problem with inappropriate comments being included in online results has improved but is still happening. Please remind all players to refrain from misusing this section of the form.
- Players playing under a false name is a serious offence. Reminder to all clubs that By-laws were introduced 18 months ago to deter this behaviour, with a 7 week suspension as the penalty.
- Be careful about the strength of emergencies used in the last few rounds. Teams will have games deducted if emergency players are seen to be strengthening the team.
- The NSNTA is an open age competition which can include juniors. However, Clubs should ensure juniors are able to cope with the standard before they take to the court.
- Additional registrations for the Ladies and Men's competitions have already closed. Mixed closes this Wednesday 29th October at 7pm. No late additional registrations will be accepted.
- Results from Round 14 must be phoned through to Peter Olney no later that 11pm on 93549019. The aim is to get the finals draw up by midnight on the night of Round 14. Teams are no longer required to phone through results for the semi or grand finals. Clubs must advise if they do not have courts available to host finals. If the Association is not advised then it is assumed that your club is able to host finals.
- Team entries for next season:
 - Ensure appropriate grade is applied for, particularly new players and teams.
 - > Give as much information about new players as possible on the entry forms.
 - > Players must be listed in alphabetical order by surname.
 - Must have Grade Contact Sheet.
 - Close 8pm on Friday 28th November 2014.
 - ➤ We will be more strictly fining misspelt names all clubs will be provided with player histories in the next few weeks to check spelling against.
 - ➤ If there are any changes to teams prior season commencing (such as withdrawals) please advise us by 13 January 2015 prior to fixtures being printed.
- Starting dates for next season:
 - Ladies: Tuesday 3rd February
 - Men's: Thursday 5th February
 - Mixed: Wednesday 11th February

- Tennis Victoria elections were held at their AGM in the 1st week of October. There were changes to the board members. Many clubs re-affiliated and there were some clubs affiliating for the first time.
- An audit was undertaken of which cubs are incorporated in the NSNTA. The only clubs found not to be incorporated were the ones that fall under the Catholic Archdiocese. Tennis Victoria has been in talks with the Catholic Archdiocese in Melbourne and an agreement has been reached where these church clubs are covered by parish insurance and can be affiliated.
