- Congratulations on no team withdrawals this season.
- Light testing is continuing. Clubs to be tested this season are Sunbury, Caroline Springs, PEGS, Rosamond, Strathmore, Diggers Rest, Mt Carmel, Coburg, Bulla Village, Royal Park, Gladstone Park.
- There have been several matches forfeited this season due to disputes over line calls, forfeited sets, players moving at the net etc. Please don't walk off the court. Try to resolve disputes.
- No percentage awarded for defaults under the current By-law. The Committee has looked at alternatives but none are suitable so there is no intention of changing the rule at this stage.
- A player cannot play in the Red team and the Black team in the one season.
- We continue to have issues with spelling of emergency player names. Pleases encourage teams to be mindful of spelling when entering results or to ask opposition if they cannot read writing.
- Spare result books were given out at the meeting to be kept in clubhouses and used if a team loses or forgets their book. Let Robert McDonald know if your club requires Ladies, Mixed or Mens books.
