#### 8. Match and Permit Committee Report

We have made changes to the online result system due to too many teams entering results for the wrong round. Now, when you select the Round, it will limit the home team options to the four teams playing at home and once you have selected the home team there is only one option for the away team. This will ensure the correct round is selected and reduce fines for clubs.

At the next meeting, the Committee will be putting up a proposed change to By-law 36 to make it easier to understand for clubs. It will clarify that if a match is incomplete, both teams will be awarded two points, unless:

- one team had an unbeatable lead; or
- after 4 sets have been completed, and any incomplete set scores are added in, one team has a lead of least eight (8) games; or
- after 5 sets have been completed, and any incomplete set score is added in, one team has a lead of least five (5) games;

then than team shall be awarded full match points.

There have been seven team withdrawals this season. In most cases this has been due to teams having too few players or clubs failing to ensure they had a definite commitment from players. Clubs are strongly encouraged to ensure they have sufficient players in teams for next season to avoid a repeat of the high number of team withdrawals.

No late additional registrations will be accepted.

If a player plays more than three emergency matches without an additional registration, the games won by that player will be deducted from the team's score.
