The Golf day was a success and it was porposed that the \$900 profit would be split between Beyond Blue and Baker Heart and Diabetes Institute

The date for the Golf Day is proposed for the 28th October 2018 with the likely cost being \$55 per player.

8. Match and Permit Committee Report

Finals last season

- The finals for last season all went relatively smoothly, and we thank all clubs that hosted.
- There were some washouts in the Mens competition, and particular thanks go to Hadfield for hosting the washed out grand finals.
- One club failed to fulfil its hosting responsibilities, so no lighting subsidy was paid.
- There were also a couple of defaults due to teams not having sufficient registered, qualified players.

Team entries

- Team entries for this season 531 teams 68 grades
 - o 142 teams in Ladies same number of teams and grades
 - o 128 teams in Mixed down 7 teams, same number of grades
 - o 261 teams in Men's up 6 teams and 1 grade

Team withdrawals

- Since the fixture was printed, the following teams have been withdrawn and replaced with a Bye:
 - o Ladies B Grade 1 Glenroy
 - Ladies B Reserve 1 St Thereses
 - Mixed B Special 2 St Monica's
 - o Mixed C Special 2 Maribyrnong Park
 - Mens A Reserve 1 Craigieburn
 - o Mens C Special 5 Mickleham Memorial
- The Committee is exploring options to stop team withdrawals as we have had six team
 withdrawals this season, following seven team withdrawals last season. Options include
 advertising for players on the NSNTA website or a pool of emergency players.
- Unfortunately, this season it has resulted in two grades Mixed B Special 2 and Mens C Special 5 – having two Byes, which means the players in those grades get less tennis.
- Once the fixture has been issued, it is very difficult to move teams between grades without adversely impacting the number of teams home and away each week at clubs.

Additional registrations

- Once again we have had a lot of additional registrations to start the season 65 additional registrations and 18 deregistrations this season.
- Three additional registrations have been refused.
- Many additional registrations are due to players being left off team entry sheets. Clubs are
 reminded that once teams have been graded, the additional registration and emergency rules
 apply, which means players cannot strengthen teams. This means that if, for example, the
 best or second best player in a team is left off the team entry form, and the team is graded
 without them, they will be refused additional registration as they will strengthen the team after
 grading. It is therefore very important that you check your team entries to ensure all players
 are included.
- We also had once instance of a player being registered in a higher team by mistake. Once a player has been submitted in a team and graded, they cannot move to a lower grade.
- Please also ensure that additional registrations are submitted before players play a fourth emergency match, otherwise teams will lose games. Matches are counted across all grades, so two matches in each of two different teams counts as four emergency matches.

Appeals

- The Committee has considered a number of appeals against the refusal of additional registrations, or emergencies being told not to play again tonight.
- These appeals seem to be becoming more frequent as clubs seem unwilling to accept the Chairman's or Coordinator's decisions.
- There seems to be a sense of entitlement with clubs expecting players can be added to teams during the season regardless of their standard.
- Clubs are reminded players do not have a right to play in the NSNTA competition unless they were listed on the team entry and are registered. All other players are subject to the rules that they cannot strengthen a team.

- The purpose of additional registrations is to assist clubs to field teams where there has been an injury or a player is unavailable. Whilst they can also be used to add new players to teams who have joined the club late, please do not promise them a place in the team as they may be knocked back if their results indicate they are strengthening a team.
- A player should not play again while an appeal is pending. The Committee meets once a
 month, so this may require a player to sit out a few rounds. If a player plays again while an
 appeal is pending, loss of games will be imposed regardless of the outcome of the appeal.

Players moving between clubs after grading

- Another issue that has arisen this season is a significant number of players wanting to move between clubs after teams have been entered and graded.
- This is possible, but it requires the club at which the player is registered to submit a
 deregistration for the player before the season starts, that is before 7 pm on Round 1. Once
 the season has started, players cannot request to change clubs.
- If they are deregistered from their original club in time, the usual emergency and additional registration rules apply and a player cannot join a team if they would strengthen it.

Clubhouse works

- Bulla Village, Royal Park and Hillside are undertaking clubhouse works this season. Toilet facilities will remain available, but there may be limited supper facilities.
- The Sunbury Clubhouse which was out of action last season has now been completed and is fantastic.

Book a court lighting issues

- A number of clubs have installed the book a court system which is connected to their lighting system. This means courts need to be booked for competition to ensure the lights come on.
- There have been several cases reported of either the lights not coming on in time, or lights going off during a match prior to the club's curfew time.
- Clubs must ensure they have appropriately tested their book a court system and that lights will be operational for competition matches. This includes adjusting the system to factor in daylight savings.

Complaints

- The Association is receiving an increasing number of emails and phone calls from players, without them informing their clubs.
- Clubs are asked to remind their players that complaints and requests for clarification of rules should only come from Club Delegates, not from players.

Multi-marked courts

- The Association has met with representatives of Tennis Victoria regarding multi-marked tennis courts. Tennis Victoria are wanting to encourage clubs to use the funding given by the government to encourage netball in Victoria. They have stated that these new courts are better quality than the previous multi marked points which were banned by the NSNTA.
- Multi-marked courts are currently not permitted under the NSNTA's policy, except for PEGS which was given permission many years ago.
- The Committee believes it should be a decision of the clubs, not the committee to change this
 policy. If a club wishes to seek approval to use multi-marked courts in the NSNTA
 competition, they will need to write to the Association and the matter would then be decided
 by the next Delegates meeting.

Autumn 2018 team fees

- Fees must be received by the Treasurer no later than 7.00 pm on Tuesday, 13th March 2018.
- Late payment will result in loss of match points. Once lost, points cannot be recovered.

9. General Business
