8. Match and Permit Committee Report

We are still having issues with players playing as an emergency for two clubs. As stated at the last meeting:

- Players cannot play at two clubs in the same competition in the same season
- This includes emergency players, so once a player has played as an emergency for one club, they cannot then switch clubs.
- If a player plays as an emergency in a grade that is too low, and are told to not play again, the rule still applies and they cannot then play at another club. Please ensure players know this.

We have issued an update to the Match and Permit Committee rulings document which can be downloaded from the website under the Rulings section. This document helps clarify the By-laws and has been issued to provide transparency in the Committee's decisions. The latest update has added that clubs must lodge an appeal against the refusal of an additional registration or a decision that an emergency player is too strong within 10 calendar days of being notified of the decision. This has also been added the additional registration form. Please ensure this timeframe is complied with.

The additional registration form has also been updated to add additional years for player history as the existing form only went up to 2017. Please download the new form and use it for future additional registrations.

Additional registrations close:

- Ladies Competition closed last Tuesday
- Mixed Competition close 7.00 pm Wednesday, 31 October 2018
- Mens Competition close 7.00 pm Thursday, 1 November 2018

No late additional registrations will be accepted.

If a player plays more than three emergency matches without an additional registration, the games won by that player will be deducted from the team's score.

Be careful about strength of emergency players in final few rounds. Teams will have games deducted if emergency players strengthen a team

- Aim to have finals draw up that night
- Clubs must advise by Monday 5 November 2018 if any courts are unavailable for finals otherwise we assume courts are available. Robert is aware of Hadfield's modgrass courts only at this stage.

- Players must be listed in alphabetical order by surname
- Must have Grade Contact Sheet
- Close 8.00 pm on Friday, 30 November 2018
- Please limit the number of special fixture requests as it makes it very difficult for the Committee to complete the draw. If too many clubs submit special requests, they cannot all be accommodated and some clubs will miss out

There have been seven team withdrawals this season. In most cases this has been due to teams having too few players or clubs failing to ensure they had a definite commitment from players. Clubs are strongly encouraged to ensure they have sufficient players in teams for next season to avoid a repeat of the high number of team withdrawals.

Start dates for next season:

- Ladies Tuesday, 5 February 2019
- Mixed Wednesday, 6 February 2019
- Men's Thursday, 31 January 2019

There will be no play on both Thursday 18 April 2019 (day before Good Friday) and Thursday 25 April 2019 (ANZAC Day). This means the Men have two weeks off in a row. The Ladies have Tuesday 23 April off (Easter Tuesday) as usual.

So that the 3 competitions all finish on the same day, the Mens start a week before the Ladies and the Mixed starts a week after that.

The pickup night for fixtures and result books for Autumn 2019 will be advised at a later date, but should be at the end of January at Airport West Tennis Club.

• In the absence of Colin Akers (Tullamarine), Larry Pelly (President) spoke about the NSNTA Charity Golf Day, which was held on Sunday 28th October 2018. "A great day of golf was enjoyed yesterday, Sunday 28th October 2018, by 82 players from 13 clubs at Melbourne Airport Golf Club. The representation of NSNTA clubs is continuing to grow. This year's competition was one by Oak Park with a decisive win by 3 strokes over the second placed team. We gain had sponsorship from Nelson Alexander real-estate and the golf club. The event has again run at a profit with initial results just over \$1100 but one entry fee is still to be resolved.
