8. Match and Permit Committee Report

COVID-19

- We are glad to be back playing again after another season was cancelled due to COVID-19.
- We have issued COVID-19 guidelines for the season, which are on the website. Masks are no longer required inside clubrooms, but it is unclear whether players still need to QR code in at tennis clubs. We will update the guidelines if this changes.
- PEGS and St Thereses require all players to be fully vaccinated to play at their venues. Please
 ensure your teams are aware of this and assist their teams to find played up players or
 emergencies if some players don't meet the vaccination requirements. If a team cannot field a
 team of players that meets the requirements listed above in order to play at one of these
 venues, they will need to forfeit.
- Club Delegates should advise the opposition Club Delegate/s and the Chairman of the Match and Permit Committee if a player who participated in an NSNTA match tests positive for COVID-19 soon after the match.

Team entries for Autumn 2022

- Team entries for this season are up by 9 teams with a total of 503 teams
 - o 122 teams in Ladies down 5 teams and 1 grade
 - o 124 teams in Mixed up 1 team
 - o 257 teams in Men's up 13 teams and 2 grades

Team withdrawals

- The following teams have withdrawn and been replaced with a Bye:
 - o Ladies B Special 2 OLN
 - o Ladies C Reserve 2 Delahey
 - Mixed A Grade Essendon (Black)
 - o Mixed B Special 1 Corpus Christi
- Unfortunately, this means there are two Byes in C Reserve 2 Ladies.

Additional registrations

- Emergencies cannot play more than three matches in total, regardless of which grades they are played in (not three matches in one grade). It is the responsibility of the Club to keep track of how many matches emergencies have played. Please ensure that additional registrations are submitted before players play a fourth match, otherwise teams will lose games.
- We have already received 80 additional registrations and 17 deregistrations this season.
- Please remember that the purpose of additional registrations is to replace injured or unavailable players. All are scrutinised to ensure they are not strengthening the team. Clubs should not expect players to be accepted just because they wanted to join a team late or a club doesn't have another team for them.

Emergencies

- Please ensure you check the history of emergency players before they play.
- Club Delegates can contact Robert of the Competiton Coordinator if they want to check the previous history of a player.
- If the Committee determined that an emergency player is stregthenig a team, the club will be warned that if they play again loss of games will be imposed. In clear cases, loss of games has been imposed without a warning being given.

Incomplete match results

• We continue to have issues with incomplete match results – particularly emergency player names missing last names. It is the responsibility of the winning team to submit a complete result, and winning team captains should not sign sheets if information is missing. The winning team will be fined for any missing details – including emergency player details of the opposition.

Light testing and automatic lights

- Thanks go to lan Openshaw who has undertaken a lot of light testing over the past 12 months.
 Disappointingly, a number of courts have failed to reach the minimum 200 lux average
 requirement. We remind clubs to continually monitor lighting levels and to proactively take
 action when required. We provide lighting reports to clubs every time we test. Please do not
 wait until a court fails before taking action.
- For clubs that are using the Book-a-Court system, please ensure you have booked your courts
 correctly. We have had issues with lights going off before the match has finished and on one
 occasion people turning up who had paid to hire the court, resulting in the home team needing
 to forfeit the remainder of a set.
