#### 6. President's Report

Larry Pelly welcomed everyone and stated that it has been 12 months since we were able to hold a Delegate's meeting in person. Thanks to Robert McDonald and all the committee for their hard work through challenging times.

2021 is the 40<sup>th</sup> Year of the NSNTA. There were plans for some celebrations this year however they have been put on hold for the time being. Hopefully later this year there will be something to mark the milestone.

#### 7. Treasurer's Report

#### 8. Match and Permit Committee Report

#### COVID-19 impact

- We thank all clubs for the cooperative way they have worked with the Association over the
  last 12 months. A number of difficult decisions have been made, sometimes as short notice.
  On occasion, we have also needed to make decisions with limited information, due to the
  unpredictable and evolving situation with COVID-19. We aim to make decisions that allow
  the competition to continue, but also protect the health and safety of players.
- We have issued COVID-19 guidelines for the season. We understand they have been working well, as we have not had any queries or concerns raised with us. One query we had was around our decision to leave the provision of supper up to clubs and teams to decide. We made this decision as each club is different, and we didn't want to deny teams the opportunity of sharing supper with their opposition if both teams wanted to do so and it could

be done safely. However, we remind clubs that the home team is not required to provide supper, and supper should not be expected.

- We had some concerns raised in relation to matches involving Sunbury teams when there were a number of exposure sites listed that were in Sunbury. One Wednesday, we cancelled two matches due to be played at Mt. Carmel as the neighbouring school had been closed for the day and it was unclear why. Going forward, we need to balance people's individual concerns about COVID-19 with the official health advice. The Committee has therefore decided that matches should proceed unless a suburb is officially declared a COVID-19 hotspot, there is official advice against travelling to an area, or the club or a nearby location is an exposure site. If clubs are in doubt, they should contact the Association. Teams should not mutually agree not to play matches without advising the Association.
- Unfortunately, we had to cancel Round 3 Ladies and Mixed matches due to the State Government imposed lockdown. We made the decision to cancel the matches and award both teams two points, to avoid the confusion of rescheduling matches and the Men's competition becoming out of sync with the other two competitions. Hopefully, there will be no further lockdowns and it will just be treated like there were blanket washouts that round. Please note, results were not required to be submitted for those matches, which means no player names were recorded. To qualify for finals, Ladies and Mixed players will now have to play 3 matches from 13 available rounds.

#### **Team entries for Autumn 2021**

- Not unexpectedly, team entries for Autumn 2021 were down, largely due to the uncertainty of COVID-19.
- Team entries for this season 494 teams 64 grades
  - o 127 teams in Ladies down 10 teams and 1 grade
  - o 123 teams in Mixed down 8 teams and 1 grade
  - o 244 teams in Men's down 10 teams and 1 grade
- We also welcome Aintree Tennis Club to the Association. After a false start in the Spring 2020 season that was cancelled, they have entered 3 Men's teams for this season.

#### **Team withdrawals**

- The following teams have withdrawn and been replaced with a Bye:
  - Ladies C Special 1 Doutta Galla
  - o Mixed B Reserve 1 Green Gully
  - o **Mens** C Special 2 Moomba Park
- Unfortunately, this means there are two Byes in B Reserve 1 Mixed.

#### Additional registrations

- Emergencies cannot play more than three matches in total, regardless of which grades they
  are played in (not three matches in one grade). It is the responsibility of the Club to keep
  track of how many matches emergencies have played. Please ensure that additional
  registrations are submitted before players play a fourth match, otherwise teams will lose
  games.
- The number of additional registrations is down so far, but we are still receiving some that are
  due to players being left off team entry sheets. Clubs a reminded that once teams have been
  graded, the additional registration and emergency rules apply, which means players cannot
  strengthen teams.

#### Light testing

Thanks go to Ian Openshaw who has undertaken a lot of light testing over the past 12 months. Disappointingly, a number of courts have failed to reach the minimum 200 lux average requirement. We remind clubs to continually monitor lighting levels and to proactively take action when required. We provide lighting reports to clubs every time we test. Please do not wait until a court fails before taking action.

#### 9. General Business

Maria Keys gave a Tennis Victoria resport – The CEO has reisgned after 2 years in the job.
 The current second in charge will assume the position for ht enext 12 months.

- Pennant entries close in early March and they will be using a slightly different format.
- The Annual Golf Day wasn't held last year due to restrictions in place at the time. There are plans for it to be held again later this year.
