# FEES 1986/87:

Proposed change to Constitution (Clause 19)

Moved by L. Pelly that Clause 19, which concerns club representation at meetings read as follows:-

"Each club shall see that they are represented at all meetings. Failure to be represented at any meeting shall result in a fine of five dollars (\$5-00)."

At present the fine is \$2-00.

Seconded by V. White Motion Carried.

## Proposed change to Rule 29

Moved by Graeme Oakes that rule 29 read as follows: -

"If in the event of unsuitable weather, lighting failure, curfew or local court limits, any HOME & HOME match is, by agreement of the captains, abandoned, whether commenced or not, each side will score two (2) points UNLESS, at the time of abandonment, one team had an unbeatable lead or at any time after the completion of the third, fourth or fifth sets, one team had a lead of at least ten (IO) games if three sets completed, at least eight games if four sets completed or five games if five sets completed, when that team shall be awarded full match points. In determining the games lead possessed by a team at the time the match is abandoned ALL GAMES MUST BE COUNTED, including those of any unfinished sets."

The following comments were made:-

Coburg - indicated that they agree to the existing rule 29 as is and that at least two (2) mixed should be played.

Parkville - indicated that to change a rule over an isolated case should not be done and that the rule should stay as is.

Seconded by R. Stewart. Motion Defeated.

Moved by M. Keys that V. White be accepted as a life member in recognition of her many years of service to the N.S.N.T.A. Seconded by L. Pelly. Motion Carried.
